Follow these steps to earn your rebate:

- 1) First verify that you qualify for Denver Water rebates! **See page 2, and / or log on to denverwater.org for complete eligibility rules.** Then purchase a qualifying wireless rain sensor between January 1 - December 31, 2009.
- 2) Attach the entire receipt, which must include the date and wireless rain sensor model number in order to qualify. **Keep a copy for your records.**
- 3) Complete this application **and the affidavit attached.** Submit a copy of your identification along with this application, the receipt, and the signed affidavit to your water provider **within 90 days of purchase date. NO EXCEPTIONS!**
Failure to cash a rebate check within 90 days of issuance shall void the rebate and shall relieve Denver Water of any obligation or liability to pay the rebate. Rebate checks cannot be reissued.

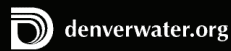

2009 CONSERVATION RESIDENTIAL REBATE PROGRAM RULES

Rebates apply only to qualifying items purchased between January 1 and December 31, 2009. **NO EXCEPTIONS!**
All 2009 applications must be postmarked by U.S. Mail within 90 days of the purchase date.

- Send rebate applications to the water provider (below) who sends your water bill. Your water provider will forward eligible applications to Denver Water for processing. If your provider is not listed below, you do not qualify for a rebate.

- **Disqualification:** If a residence has received a rebate since December 31, 2002 for the following:
 • 3 Toilets • 1 ET Controller • 1 Rain Sensor • 1 Clothes Washer
the residence is ineligible to receive the same rebate as part of the 2009 rebate program.

- Customers applying for a rebate agree to allow Denver Water employees to access their premises in order to verify installation of devices eligible for rebates.
- All application forms must be accompanied by an original sales receipt. A valid receipt must clearly show date purchased, manufacturer name/make, model number and price for each item. Application forms without complete information or a valid receipt will be returned. **Please keep a copy for your personal records.**

DENVER WATER REBATE AFFIDAVIT

As of July 31, 2006, you must prove lawful presence in the United States in order to receive the benefit of the rebate.

At the time this form was printed, forms of identification acceptable to the Colorado Department of Revenue include:

- a valid Colorado driver's license;
- a valid Colorado identification card;
- a current driver's license or identification card with applicant's photograph issued by one of the following: Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming;
- United States Passport (except "limited" – issued for 5 years or less);
- a United States military card;
- a United States military dependent's identification card;
- a United States Coast Guard Merchant Mariner card;
- a Native American tribal document;
- a naturalization or citizenship certificate;
- an I-94 immigration form with refugee or asylum status; or
- an unexpired resident alien card, permanent resident card, temporary resident card, or employment authorization card;
- any other form authorized by the [Colorado Department of Revenue](#).

Please mail a photocopy of your identification (in one of the forms listed above) and your signed affidavit along with the other rebate paperwork. **We assure you that this information will remain confidential. You may remove/darken all sensitive information such as driver's license numbers or social security numbers from the copy of your ID that you submit to Denver Water.**

In addition, you must sign and return the affidavit below:

AFFIDAVIT

I, _____ (print name legibly), swear or affirm under penalty of perjury under the laws of the State of Colorado that (check only one):

I am a United States citizen, or

I am not a United States citizen, but I am a Permanent Resident of the United States, or

I am not a United States citizen, but I am lawfully present in the United States pursuant to Federal law.

I understand that this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
